**REVISED TAXES & DUTIES :-**

IF THE RATE QUOTED BY THE BIDDER IS LESS THAN 15% OF THE ESTIMATED COST, THAN SUCH A BID SHALL BE REJECTED AND THE TENDER SHALL BE FINALISED BASED ON MERITS OF REST BIDS. BUT IF MORE THAN ONE BID IS QUOTED AT 14.99% ( DECIMALS UP TO TWO NUMBERS WILL BE TAKEN FOR ALL PRACTICAL PURPOSES) LESS THAN THE ESTIMATED COST, THE TENDERACCEPTING AUTHORITY WILL FINALIZE THE TENDER THROUGH TRANSPARENT LOTTERY SYSTEM, WHERE ALL BIDDERS / THEIR AUTHORISED REPRESENTATIVES, THE CONCERNED TENDER COMMITTEE WILL REMAIN PRESENT.
